It safeguards the student from any intermediate administrative notices, payment follow-ups, or logistical distractions, allowing them to remain solely focused on their academic performance.
- 5. Self-Consent on Advance Payment & Policies:** I explicitly authorize the hostel administration to accept the full session fee in advance.
