

BOND OF UNDERTAKING

aged about years, residing at hereinafter referred to as the 'Guarantor' to here by undertake and bind myself as detailed in this CAREER DEFENCE SCHOOL.

Whereas, I wish to admit by daughter/son hereinafter referred to as the 'Student', to CAREER DEFENCE SCHOOL, CAREER DEFENCE SCHOOL is a Residential School for Boys as well as Girls.

Where, at the request of the Guarantor, the Student has been Selected for admission in the institution, on the terms and condition as may be guttered from the prospectus and the following specific undertaking of the Guarantor:

UNDERTAKING/TERMS AND CONDITIONS:

- The Guarantor shall make payment of all the fees and charges, before the specified dates to the institution, The Guarantor accepts that the fees and 1. charges may be increased by the Board of Governors, Career Infowis Committee, to maintain and keep up to the standards (in teaching, administration and infrastructure) of the institution. The Guarantor agrees to pay such additional fee or charges levied, within such time as stipulated.
- 2. If at the time after the admission it is found that any of the documents like the proof of the domicile, certificate of age, date of birth, caste certificate, income certificate, or any certificate document required for the purpose of admission of proof of whatever nature, of the Students is/are found to be false, then the student shall be removed from the rolles of the institution even during the currency of the academic year) at the sole discretion of the Principal of the Institution. In such a situation Transfer Certificate will be issued only after payment of all the fees and charges and there shall be no refund of any fees and charges whatsoever, paid earlier.
- That, as stipulated in item No. 1 above, the Guarantor undertakes to make payments of tall the fees and charges to the Institution in one Installment 3 before specified date, in default, the Principal of the Institution may levy penalty and if necessary may order of the removal of the Student from the Institution.
- That, I Guarantor agrees to defray the costs of any co-curriculum or extra-curricular activities as may be introduced by the institution and as specified 4. from time to time
- That, the Guarantor authorities the Institution to deduct any fees or/and other charges from the Students Pocket's Money Account. 5
- The Guarantor fully understands and agree that the Student's continuance in the Institution is subject to her passing previous year's examination, as 6. per the promotion policy of the school of Principal to improve/levy such penalty, including the penalty of removing the Student from the Institution. That, if at the time causes any damage to any property of the Institution/Society, the Guarantor shall make payment of the necessary costs as may be
- 7 fixed by the Principal of the Institution, Immediately on demand in default, the Principal way take such necessary action, including the costs from the Pocket Money Account of the student or removing the Student from the institution or withholding of Transfer Certificate till such time the costs as specified are not paid.
- That, if at any time after the admission of the Student it is found the Student is suffering from the disease/ailment/physical incapacity, which affects the 8 student's participation in the Curricular, Co-Curricular or extra Curricular activities and the lodging and boarding environment of other Student of the Residential School, the Principal may order for the removal of the student from the institution and Fees or charges will not be refunded whatsoever. The Guarantor agrees that the Board of Governors, the Society, the Principal or the Institution shall not be liable for any damages / costs / charges /
- 9 compensation on account of any injury, including those resulting in disability, fatality, etc. This may be sustained by the Student, while participating in any Curricular, Co-curricular, Extra Curricular, Sports, Swimming, Horse Riding, Rock Climbing, Mountaineering, Cycling, Excursions, Educational cum Motivational Trips, Adventure Activities etc. The cost of treating the injury / injuries or any other charges shall be borne solely by the Guarantor and any charges / fees.
- The Guarantor hereby gives consent to the Institution to take the student for any trip, Excursion Tours, Sports Meet, Adventure Activities etc. In case 10. of any injury / fatality to of the student, during such activities, the Guarantor agrees that the institution / Society is not responsible or liable in any way. The Guarantee authorizes the institution to give consent as Guardian of the student for such trip/trip activities/Medical Treatment etc to any Government / authority, if required.
- The Guarantor hereby authorizes the Principal or any other authority of the institution / Society to sign and as act Guardian of the student, in and on all 11. certificate, documents connected with the various examinations (like AISSE/AISSCE/CET/NTSE/ComedK / JEE/AFMC etc.)
- The Guarantor agrees that in the event of the Student not attending / joining the institution or withdrawing from the institution for reasons whatsoever, 12 the fees and charges or part there of shall not be refunded and in case there is any balance to he paid to the Institution with regard to the fees and or other charges, the Transfer Certificate will be issued only after the clearance of the dues. The balance to be paid to the institution may also be deducted from the Pocket Money Account will be refunded. The Guarantor agrees and undertakes that he/she or the student shall not be entitled to any refund of any fees or charges whatsoever, if the Guarantor/Student withdraws from the institution for reasons whatsoever is removed from the institution
- That the Guarantor understand and agrees that it shall be the responsibility of the Parent / Guardian / Guarantor to escort the student to and from the 13. institution on vacation breaks, permitted leave period etc. If this is cot possible for unavoidable reason, a close relative of the Student will be sent for this purpose, with a letter of authority of the Guarantor / Parent and a signed photo of such close relative will be affixed on the letter of authority.
- The Guarantor understands and agrees that the Principal / institution / Board of Governors / Society are entitled to take any decision in the interest of 14. Student and / or the Institution on the mattes not covered in this Bond of Undertaking and the Guarantor and the student shall abide by it.
- The Guarantor hereby agrees that, if there is any dispute with regard to any matter covered herein matters regarding the admission, continuation, residence, food, accommodation, amenities, facilities, curricular, co-curricular, extra-curricular activities, removal of the student from the institution, 15. fees, charges, penalties, issuance or non issuance of Transfer Certificate, then it shall be referred to a sole arbitrator as appointed by the Board of Governors. The decision of the Arbitrator shall be final and binding on all the parties concerned including the Guarantor / Student / Parent / Guardian and the institution. The provision of the Arbitration and Cancellation Act, 1996 shall apply. The place of Arbitration, which shall be final and shall bind the Guarantor / Student / Parent / Guardian or any Person, authority on behalf of the Student. In the Student leaves the School without the Guarantor paying full fees. Principal is authorized to take any suitable legal action on the Guarantor /
- 16. Cadet for the costs and consequences where the Guarantor alone is liable / responsible.
- 17. If Guarantor meets personally to cadet, and hands over her any medicines, tablets, syrups and any eatables without knowledge of the School Doctor, then the Guarantor is fully responsible for act of Cadet / Guarantor if anything happens to the Cadet.
- Guarantor is fully aware and agrees that on alternate Second Sundays/Parents Meet only Father/Mother is allowed to meet Cadet, no relatives will be allowed inside the Campus. 18

- 19. The entire fees will have to be deposited by the student in one lump at the time of admission and thereafter every year at the beginning of the academic session as per communication send by the Accounts Wing of the School.
- 20. The Guarantor hereby agrees and undertakes that, expect the place of Arbitration as may be decided as specified in the paragraph above, all disputes, including consumer disputes, are subject to the courts/Forms/Authorities in the Career infowis Institution jurisdiction only. That, the content of this Bond of undertaking have been read over to the guarantor in his/her vernacular language and the Guarantor has understood the same and has after understanding and accepting / agreeing for the same, has put his/her signature to this Bond of Undertaking, thereby binding himself/herself to the undertakings/terms and conditions as a specified herein.
- 21. The Guarantor is responsible to fill all the forms. Career Group is not responsible for any form. Career Group Only Guides the Parents for fill their forms.
- 22. The guarantor agree that if there ward suffer from any disease or illness, career group provide first Aid facility and rest of the expenses will be paid by the guarantor and guarantor left their child on their own responsibility.
